- I accept for use, as-is, the boat & equipment I receive, and accept full responsibility for the care and return of the boat and all equipment.
 - I agree to pay for any loss or damage other than ordinary wear resulting from possession and/or use.
 - I understand that boating presents certain dangers. I represent to NH Audubon that I possess basic skills and experience for the safe operation of the below boat(s).
 - I agree that I, and all persons aboard, will wear the Personal Floatation Device (PFD) provided, or US Coast Guard approved PFD which I am providing myself, at all times while afloat.
 - There is no guarantee of safety. Weather conditions, the behavior of watercraft operators and others on the waterways, and other circumstances may contribute to a risk of injury or death.
 - I release NH Audubon and its officers, directors, and employees from any claim of liability for damage or injury to myself or any other person or property resulting from negligence in provision of the boat and equipment to me, or from the condition of any land, dock, or waterway.
 - I further agree to defend and indemnify NH Audubon for any loss or damage arising from claims or lawsuits for personal injury, death, and property loss and damage related to use of this equipment and participation in recreational activities.
 - In an emergency, I understand that NH Audubon will not be able to assist me out in the water. I will contact 9-1-1
 - **I FULLY ACCEPT ALL RESPONSIBILITY FOR ANY AND ALL DAMAGE OR INJURY.**
- Late Fee:** A \$10 late fee may be charged for equipment returned after the rental period.
Refunds for reservation cancellations: 24 hours prior = full refund; Less than 24 hours prior = 50% refund.
